Data to Angus Genetics, Inc—Aug 15th

Due to the lateness of the convention this year, we have post-poned sending the data to Angus Genetics until August 15th. If you want your data to be analyzed for EPDs, you must send the information to the SCBA office no later than August 2nd. If you enter your data into the database your-

self, you have until August 14th at midnight to get the data in.

NOTE: All animals are sent to AGI for analysis automatically. To add new data, simply register your cattle, or add birth, weaning or yearling dates.

Election Results

During the Convention in Bogota, Colombia, the 2012-2013 President, Mr. Sebastiao De Aguiar resigned from the Board of Directors, which was quite a surprise for the membership and Directors. He informed the membership that his reasons for his decision were based primarily upon family issues. He also noted that he has a difference of opinion regarding the direction of the Association and did not wish to continue.

Because of Mr. De Aguiar's resignation, his one (1) year term was vacant and needed to be filled. According to our by-laws, when there is a vacant term, of the winners of the election, those who win the least number of votes, will be elected to fill the one year position on the board.

As a recap, the nominating committee selected the following people for the ballot: Mr. Hans Lawaetz (USVI), who by virtue of the by-laws is automatically elected to the Board because he is from the Island

of St. Croix, Mr. Patricio Pitti (USA/Panama), Dr. John DeGroote (USA), and Mr. Carl Parker (USA). From the floor of the assembly, the following people were nominated: Mr. Andres Garcia (Costa Rica), Col. Carlos Jimenez (Venezuela) and Mr. Mark Sanders (USA).

The ballots were counted by the following committee: Dr. Anneris Paredes-Zaglul (Nominating Committee), Mrs. Lisa Vorce (Executive VP of SCBA), Mr. Ronnie King (Director, SCBA), Mrs. Beatriz Diaz (Member, Venezuela). The results were as follows:

The Directors for 3 year Term are: Mr. Hans Lawaetz, Mr. Patricio Pitti, Dr. John DeGroote and Mr. Andres Garcia. The Director for 1 year Term is: Mr. Carl Parker.
